AT: LACKING EFFECTIVENESS (CON)

WHEN YOU CONSIDER... Surveillance systems are only effective a small percentage of the time because cameras can cover only about 10% of the border and are often hindered by bad weather or poor image quality,

DON'T YOU THINK... Increasing US border surveillance will waste billions of dollars because it fails to effectively prevent unauthorized border crossings?

Technological Advancements

WE DISAGREE! OUR RESEARCH SAYS... Advanced border surveillance technology has made significant progress in recent years because new systems can detect unauthorized crossings more effectively, even in challenging weather conditions.
