This means... Increasing US border surveillance will harm millions of taxpayers because their money is being wasted on ineffective systems, taking funds away from higher priorities like schools, hospitals, and roads.

Finally... Disproving My Opponents' Rebuttals

This means... expanding border surveillance could result in thousands of innocent people being falsely accused of illegal activities, potentially leading to wrongful detentions or even arrests, causing serious harm to their lives and reputations.

Finally... Disproving My Opponents' Rebuttals

1. First... Not Enough Privacy Protection: The current laws don't stop all the private information these systems collect about people.
2. Also... Technology Still Makes Errors: Even a few mistakes can hurt many people since thousands are crossing the border.
3. Finally... Dangerous Crossings Continue: More watching often pushes people trying to cross to take more dangerous paths, not stop them. This leads to more people getting hurt or even dying.
